Follow up with Emails with documents

## Good evening,

I am submitting the petition, the brief and the mail receipt of the documents that were submitted to Jeremy Cockrill of the Legislative Assembly of Saskatchewan for petition for redress of grievances based on the Westminster Parliamentary common law dating back to 1640. Since this was submitted to the agents of MLA Jeremy Cockrill by hand on October 11, 2024, it is the obligation of all 61 members to bring this to the floor. Since it is the people who submit the petition who determine its urgency, this is not a matter for the elected officials to decide. It is the obligation to put it to the floor.

Since the petition outlines a matter that is outline in Article VI section 92(14) under the exclusive powers of the provincial legislatures pursuant to the constitution act 1867, it is only the legislative assembly of Saskatchewan that has the lawful capacity to entertain this matter. As it outlines that on Part VII section 52(1) of the constitution act 1982, any law that is in contradiction to the Constitution of Canada is of no force. Since the RCMP are not under the exclusive control of the province of Saskatchewan the administration of justice is not under the control of legislative assembly as outlined as exclusive powers set forth is that aforementioned section of the act. Therefore it is an urgent matter to deal with since actions of the RCMP who are operating without a law in force have suppressed a delivery system for biological weapons handed over to the Chinese at the Winnipeg biolab as the documents put out by Pierre Poilievre on the our commons website. https://www.ourcommons.ca/content/Committee/432/CACN/WebDoc/WD11405787/11405787/

This information is the subject of high treason complaints against Premier Scott Moe who has concealed this information since his office being given this information since 2020 and it was placed into his hands at a town hall at Speers, SK in April of 2024. https://x.com/DjsRichardson/status/1784867702567285235

Since the documents contained evidence of a delivery system for biological weapons that was implemented for the biological weapons handed over to the Chinese at the biolabs in Winnipeg, impeding the documentation is giving aid and comfort to those who are subject to the investigations. Rogue members of the Battlefords RCMP including detachment commander Inspector Jesse Gilbert are involved in the suppression of the delivery system that was reported by Dale J. Richardson on July 3, 2020, for criminal complaints. There has been a long history of reporting this information and nothing has been done.

This information will be provided to the public and any other interested party to distribute as necessary.

This is not the actions of a government operating within the confines of the law and the constitution of Canada. Now that it has come to the attention of all of the members, the obligation is upon the legislative assembly of Saskatchewan to fix the issue.

You have been informed of your duty. The public will continue to demand this petition be brought to the floor until the duty has been discharged.
